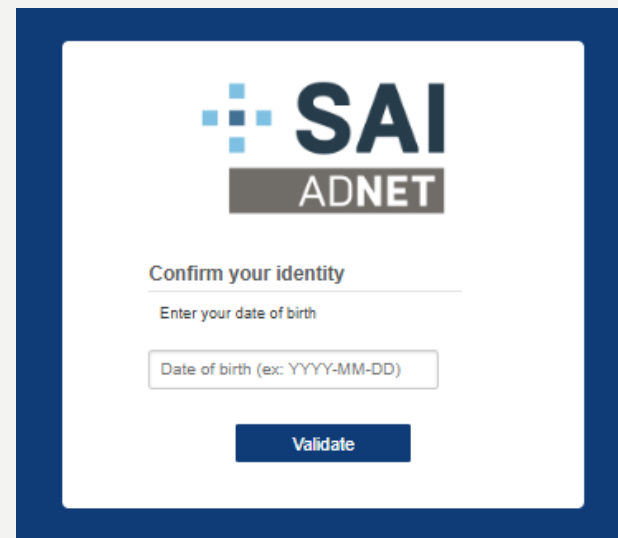

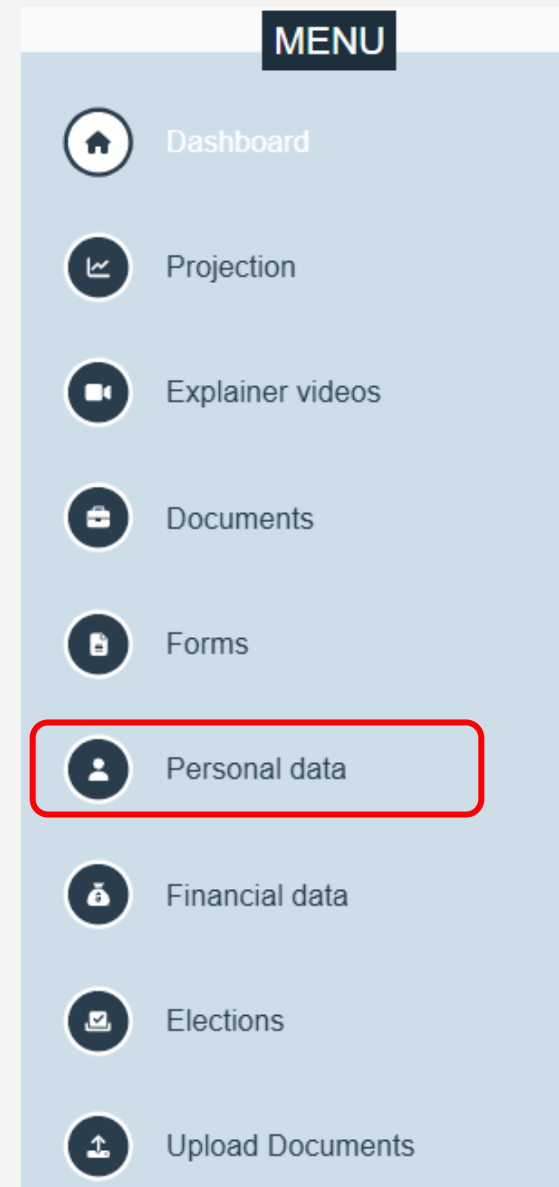

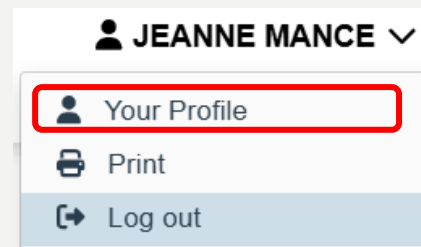

Transmission of Documents

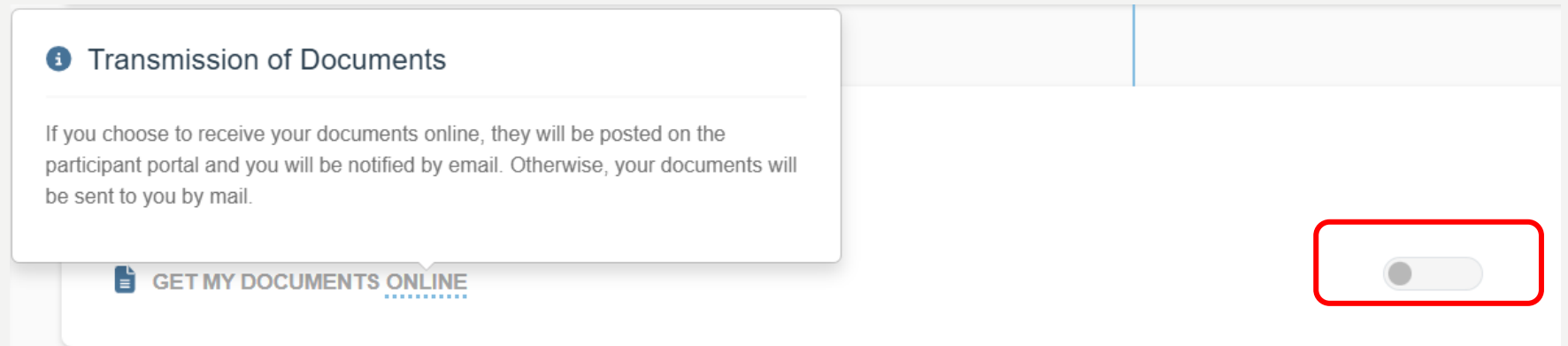
